**A \$500 deposit is required to secure your child's event. Balance payment is required 10 days prior.**

## **Cancellation policy**

8 weeks prior - \$450 of deposit refunded, with \$50 administration fee

2 - 8 weeks prior - deposit will be forfeited in full

Less than 2 weeks - deposit forfeited and cancellation fee equivalent to 50% minimum spend

**Please note:** If your event is unable to go ahead due to Government Restrictions (reduced patronage and closure of function spaces or restaurants) we will be able to either refund the full deposit/and any final payments paid or move it to another available date. Please note that due to a change of mind or cancellation from the client, the regular terms and conditions will come into effect. These include forfeiting the deposit if you decide to cancel your function within 8 weeks of the function date.

All details including final guest numbers are to be confirmed 14 days prior.

## **Allergies**

Please be aware that all care is taken when catering for special requirements. It must be noted that within the premises we handle nuts, seafood, shellfish, sesame seeds, wheat flour, eggs, fungi and dairy products. While customer requests will be catered for to the best of our ability the decision to consume a meal is the responsibility of the customer.

Children over 2 years are considered guests and are therefore included in your final guest numbers. If a guest cannot attend on the day, confirmed booking numbers will still apply.

The Deck Cafe is available for parents and friends to enjoy barista made coffee and all day brunch menu whilst their children attend a party.

You are welcome to arrive 15 minutes before the party starting time to drop off the birthday cake and settle in, then your party space will open to guests 5 minutes before the party start time.

To ensure the safety and wellbeing of all your guests, two responsible adults must be present for the duration of the event.

We suggest taking all belongings at the end of your party, if any equipment and/or props are left at the venue we cannot be held responsible for any damages or losses. If damage is caused by any guests during the course of the party, the organiser may be liable to pay for repairs or replacement.
